New Business

A. Discuss /Take Action 2019 Certified Tax Roll

Attorney Charlie Stevenson read the resolution Brazoria County Appraiser certifying the tax roll.

Neal Bess Jr. made a motion to accept the resolution for the 2019 Certified Tax Roll. Tim Pettigrew seconded. All were in favor.

B. Discuss / Take Action Set Tax Rate Fiscal Year 2019-2020. Schedule Public Hearing If Necessary.

Mayor Farley addressed council this item is to set our proposed tax rate for 2019-2020 at .747062. This will have a 4.91% increase in taxes for next year. We will schedule two public hearing and must complete by next month council meeting.

Brian Brooks made a motion to accept the proposed tax rate of .747062 which is a 4.91% increase and set two public hearings. Neal Bess Jr. seconded.

Sandra Blaine voted yes. Neal Bess Jr. voted yes. Brian Brooks voted yes. John Rambo voted yes. Tim Pettigrew voted yes. All were in favor. Motion carried.

C. Discuss /Take Action Re-Zone Sweeny Block Lot 25-26 From C1 to R2B (John Millsap)

Mr. Millsap spoke to the council that he owns property on 1st Street behind Kessler Insurance. Mr. Millsap want to re-zone this lot from commercial C1 to residential R2B.

Planning and Zoning Board has given approval. Charlie Stevenson stated we needed to have a Public Hearing first then council can if they so choose to approve. We will have a public hearing first at our next scheduled council meeting in September.

D. Discuss / Take Action City Award Bid for Water Plant Generator

Mayor Farley stated the city received three bids. 1.) Trident Building Services for \$109,384.00. 2.) C.F. McDonald Electric \$118,469.00. 3.) Waukesha Pearce \$99,674.00. Ms. Minshew reminded the council we received a grant for \$91K so we will pay the balance of \$8,674.00.

Neal Bess Jr. made a motion to approve Waukesha Pearce for \$99,674.00 for the Water Plant Generator. Tim Pettigrew seconded. All were in favor. Motion carried.

E. Discuss/ Take Action Sale of Silverleaf Lot

Ms. Minshew stated this is a lot on Silverleaf that is owned by The City of Sweeny. It was going to be used as a playground/ park when the Windmill Run Apartments were built in the late 1990's. A citizen has contacted the city and asked to purchase the lot. Mayor Farley stated we need to go out for bids and set a minimum price. This will get this lot back on the tax roll and maybe a home will be built on it.

Brazoria County CAD has the lot appraised for \$2500. A smaller lot next to it appraises for \$14,900.00.

Brian Brooks made a motion to go out for bids on this lot on Silverleaf and to set a minimum bid of \$10k. Neal Bess Jr. seconded. None were in favor of the motion. Motion dies.

Neal Bess Jr. made a motion to go out for bids on this lot on Silverleaf and to set a minimum bid of \$10K. The city council has the right to accept or reject all bids. Brian Brooks seconded. All were in favor. Motion carried.

F. Discuss / Take Action Council List of Projects (Tim Pettigrew)

Councilman Pettigrew asked each council member to give Reatta a list of projects they would like the City Manager take action on.

G. Discuss /Take Action Remove Cindy King from 1st State Bank Accounts and Add Laurie Martinez to 1st State Bank Accounts

H. Discuss/ Take Action to Continue Waving Building / Tap Fee's for New Residential Homes

Council discussed pros and cons whether to continue to wave the building and tap fees for new residential homes. They were spilt with some for and some not. No motion was made. Agenda item dies for lack of motion. Waving the building permits and tap fees for new residential homes expires October 1.2019.

I. Discuss/ Take Action Resignation Betty Liles from Planning Board of Commissioners.

Neal Bess Jr. made a motion to accept the resignation from Betty Liles from Planning Board of Commissioners. Tim Pettigrew seconded. All were in favor. Motion carried.

J. Discuss /Take Action on Applications Received for City Manager

Mayor Farley had discussion with council that he received 32 applications. He asked each council member to pick their top five and we will schedule a special meeting soon to start the process of review and interviews.
